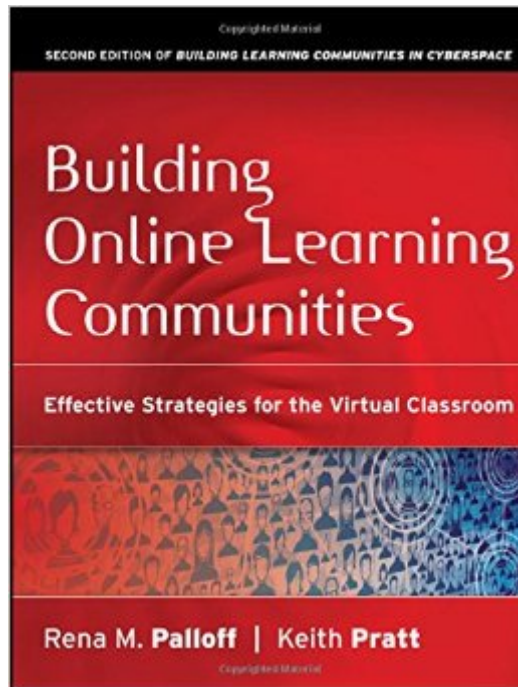

that I currently am an online facilitator and have also taken online classes to be an online facilitator and found this book to be a friendly reminder, backed up by plenty of research and personal testimonies, on how a successful learning community should be conducted. I believe the purpose of this book is to share effective strategies for the virtual classroom (as its subtitle indicates). Its purpose is not to tell you how to create an online class, but how to build a successful community. The authors communicate several important aspects of a professional learning community through online learning. They make a great effort to help readers understand the transition for face to face learners to virtual learners. They also make it very clear that online facilitators need to be just that. Facilitators. Online learning is meant to be facilitated in a constructivist approach, where the learners take control and responsibility of their own learning through inquiry, collaboration and self-reflection. Online students learn from each other. Yes, this may be very cut and dry to those of us that have taught online successfully; however, the approach they take with their studies and integration of actual student interaction is helpful as it is analyzed thoroughly throughout the book for readers to have a better understanding of how to approach and meet the needs of their different online learners.
